

Click&Boat Game Official Rules

▼ ARTICLE 1: ORGANIZATION

CLICKANDBOAT, a simplified joint-stock company (Société par Actions Simplifiée) with a share capital of €6,466, registered with the Nanterre Trade and Companies Register under number 801 157 256, having its registered office at Quai du 4 Septembre, 92100 Boulogne-Billancourt, France (hereinafter referred to as the "Promoter"), is organizing a free prize promotion with no purchase necessary entitled "Click&Boat Game" (hereinafter referred to as the "Game"), from 6 July 2026 at 10:00 a.m. (CEST) until 16 August 2026 at 11:59 p.m. (CEST) inclusive (hereinafter referred to as the "Promotion Period").

Any person participating in the Game should read these Official Rules (hereinafter referred to as the "Rules") in order to become familiar with the participation requirements. Participation in the Game constitutes the Participant's full and unconditional acceptance of these Rules and of all applicable laws and regulations governing this Game.

The Game is open to any individual aged eighteen (18) years or older on the date of entry, residing in France, Spain, Italy, or any other country within Europe, hereinafter referred to collectively as the "Participants" and individually as a "Participant".

The Promoter reserves the right to extend, shorten, amend, suspend or cancel the Game at any time, in particular in the event of force majeure, unforeseen circumstances or any event beyond its reasonable control.

▼ ARTICLE 2: ELIGIBILITY

To be eligible to participate, each Participant must satisfy the eligibility requirements set out herein. No entry fee or purchase is required to participate

in the Game. Eligible Participants may enter the Game by following the participation procedure described in Article 3.

The Game is open to any individual aged eighteen (18) years or older on the date of entry (hereinafter referred to collectively as the "Participants" and individually as a "Participant") residing in France, Spain, Italy, or any other country within Europe. The Promoter reserves the right to require any Participant to provide proof that the eligibility requirements set out above have been satisfied. Any person who does not meet these requirements, or who refuses to provide such proof, shall be excluded from the Game and, if applicable, shall forfeit any Prize awarded.

Only one (1) entry per individual is permitted. Participants undertake not to submit multiple entries by using different names, postal addresses or email addresses. Participants are prohibited from creating multiple accounts in order to enter the Game more than once. Any Participant using multiple accounts shall be deemed ineligible and excluded from the Game.

The Promoter reserves the right to carry out any verification necessary to ensure compliance with this rule. Participants expressly authorize such verification.

Participation in the Game requires Internet access. Certain features of the Game may invite Participants to interact with social media platforms or to share the Game. Participants are solely responsible for creating and using any services or platforms necessary to participate. Under no circumstances shall the Promoter be held liable for any malfunction of such platforms or for any difficulties encountered by Participants in using them.

By participating in the Game, each Participant declares and warrants that they satisfy all eligibility requirements.

The Promoter may, at any time, require Participants to provide proof of their eligibility, including proof of identity and age.

Any refusal to provide such information, or any false declaration, shall result in the automatic exclusion of the Participant from the Game and the forfeiture of any Prize. Such exclusion shall apply automatically and without prejudice to any legal remedies available to the Promoter.

Participants may enter the Game only once during the Promotion Period and subject to compliance with the participation procedure.

Participation in the Game is available exclusively through digital means.

Employees of the Promoter, its parent companies, subsidiaries, affiliated companies, suppliers, service providers, and members of their immediate families are not eligible to participate in the Game.

▼ **ARTICLE 3: HOW TO ENTER**

In addition to satisfying the eligibility requirements set out above, Participants must, during the Promotion Period, visit the following website:

- provide a valid email address in order to participate in the Game;
- click the “Play” button to start the Game. By clicking the “Play” button, the Participant acknowledges having read and fully accepted these Official Rules;
- complete the observation game by finding all nine (9) hidden items in the illustration before 16 August 2026 at 11:59 p.m. (CEST);
- complete the participation form by providing:
 - first name;
 - last name;
 - date of birth;
 - telephone number.

Participants may also, on a voluntary basis:

- follow the official Click&Boat Instagram account;
- share the Game with friends using the URL provided.

These actions are optional and have no impact on eligibility for the Prize Draw.

Eligible participants who successfully complete the entire Game and submit the participation form will automatically be entered into the Prize Draw.

Participants who complete the Game and comment on the official Instagram post relating to the campaign will receive an exclusive promotional code offered by Click&Boat, subject to these Official Rules.

Any late, incomplete, inaccurate or non-compliant entry shall be deemed invalid and will not be taken into consideration. The Promoter reserves the right to disqualify any Participant suspected of fraud without prior notice or justification. Any incomplete, inaccurate, illegible or otherwise invalid entry, whether intentional or not, or any entry submitted in a manner inconsistent with these Official Rules, shall be declared void. The same shall apply to multiple entries.

The Promoter shall not be liable for any lost, delayed, misdirected, invalid, corrupted or otherwise unusable entries, regardless of the cause.

The collection of the personal information requested as part of the Game is mandatory, as such information is necessary for the administration of the Game and the awarding of the Prize.

Such personal data shall be collected and processed in accordance with these Official Rules.

Participants agree that:

- their entry shall not contain any threatening, defamatory, obscene or pornographic content, or any content that may encourage unlawful conduct or otherwise be intended to harm the Promoter or any third party;
- their entry shall not contain any virus, commercial solicitation, chain letter, mass mailing or any other form of spam;
- they shall not use a false email address, impersonate another person or entity, or otherwise mislead the Promoter as to the origin of their entry.

This Game is in no way sponsored, endorsed, administered by, or associated with Instagram. Instagram shall bear no responsibility for the organization or operation of the Game.

▼ ARTICLE 4: PRIZES

The value of the Prize(s) is determined at the time these Official Rules are published and may not be challenged.

The Prizes are as follows:

→ **PRIZE 1: One (1) Winner**

One (1) gift voucher with a value of €1,000 (VAT included), valid until 31 August 2027, which may be used to book a boat trip available through the Click&Boat platform, subject to Click&Boat's Terms and Conditions of Use and applicable commercial conditions at the time of booking.

→ **PRIZE 2**

All Participants who complete the Game and comment on the official Instagram post relating to the campaign will receive an exclusive promotional code granting 10% off a booking made through the Click&Boat platform, subject to Click&Boat's Terms and Conditions of Use and applicable commercial conditions.

The promotional code is personal, non-transferable, may not be exchanged for cash or any other consideration, and may not give rise to any refund.

▼ **ARTICLE 5: WINNER SELECTION**

One (1) Winner will be selected by random draw on **18 August 2026** from among all eligible Participants who have successfully completed the Game and submitted a valid entry in accordance with these Official Rules.

The Prize Draw will be conducted by the Promoter. The result of the Prize Draw shall be final and binding, and no correspondence or appeal will be entered into regarding its outcome.

▼ **ARTICLE 6: WINNER NOTIFICATION**

The Winner will be confirmed only after verification of their eligibility.

The selected Participant will be contacted by the Promoter by email for the purpose of awarding the Prize.

▼ **ARTICLE 7: PRIZE FULFILMENT**

The Winner will be contacted by the Promoter and assisted with the arrangements necessary to receive the Prize.

The Winner agrees to accept the Prize as offered and acknowledges that it may not be exchanged, transferred, assigned, redeemed for cash or substituted for any other goods or services. No compensation or alternative Prize shall be provided.

The Promoter reserves the right, in the event of circumstances beyond its reasonable control, including but not limited to supplier-related issues or other unforeseen events, to substitute the advertised Prize with another prize of equivalent value. The Winner will be informed of any such substitution.

If the Winner fails to respond within sixty (60) days of being notified of the Prize, the Prize shall be deemed forfeited.

▼ **ARTICLE 8: PERSONAL DATA**

The personal information provided by Participants is collected and processed by the Promoter for the purposes of verifying eligibility, recording participation in the Game and administering the Prize.

The personal data collected in connection with the Game includes, in particular:

- email address;
- first name;
- last name;
- date of birth;
- telephone number;
- newsletter subscription preference.

The data is collected and processed by CLICKANDBOAT, acting as data controller, for the purposes of administering the Game, selecting the Winner, awarding the Prize and, where the Participant has given their consent, sending marketing communications.

Personal data will be retained for the period necessary to administer the Game and thereafter archived in accordance with applicable legal requirements.

Participants may object to the processing of their personal data collected in connection with the Game. They also have the right to object to the use of their personal data for direct marketing purposes outside the scope of the Game. Such rights may be exercised by contacting the Promoter by email at: socialmedia@clickandboat.com.

The Winner authorizes the Promoter to use their first name, last name, email address and social media username for advertising and public relations purposes, in any media and without additional compensation or consideration other than the awarding of the Prize.

In accordance with the French Data Protection Act and Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation – GDPR), Participants have the right to access, rectify, erase, restrict or object to the processing of their personal data, withdraw their consent at any time where applicable, and exercise their right to data portability by contacting the Promoter at: socialmedia@clickandboat.com.

▼ ARTICLE 9: OFFICIAL RULES

These Official Rules are available on the Game homepage prior to participation.

The Promoter reserves the right to extend, shorten, amend, suspend or cancel the Game at any time, in particular in the event of force majeure or circumstances beyond its reasonable control, without incurring any liability towards Participants.

Any amendment to these Official Rules will be published on the Game page. Continued participation in the Game following the publication of any such amendment shall constitute acceptance of the revised Official Rules.

▼ ARTICLE 10: INTELLECTUAL PROPERTY

Any reproduction, representation or exploitation, whether in whole or in part, of any element of the Game, including these Official Rules, is strictly prohibited.

All trademarks, logos, texts, images, videos and other distinctive signs displayed on the Game website or on any website accessible through hyperlinks are the exclusive property of their respective owners and are protected by applicable intellectual property laws throughout the world. Any unauthorized reproduction constitutes an infringement and may give rise to civil and/or criminal liability.

Any unauthorized reproduction, whether in whole or in part, of such trademarks, logos or other distinctive signs constitutes an infringement and may be subject to legal proceedings.

Participation in the Game constitutes full and unconditional acceptance of these Official Rules.

▼ ARTICLE 11: LIMITATION OF LIABILITY

Upon receipt of the Prize, the Winner agrees to release and hold harmless the Promoter, its parent companies, subsidiaries, affiliated companies, suppliers, service providers, commercial partners and their respective directors, officers, employees and representatives (collectively, the "Released Parties") from and against any and all claims, actions, damages, losses or liabilities arising out of or relating to participation in the Game, the acceptance, use or misuse of the Prize.

The Released Parties shall not be liable for:

- any incorrect or inaccurate information resulting from (i) Participants, (ii) printing errors, or (iii) any equipment or software associated with or used in connection with the Game;
- any unauthorized human intervention in any part of the entry process or the operation of the Game;
- any modification, suspension or cancellation of the Game resulting from force majeure or any unforeseen circumstances beyond the Promoter's reasonable control;

- any technical or human error occurring in the administration of the Game or the processing of entries;
- any direct or indirect loss or damage arising from participation in the Game or from the acceptance, use or inability to use the Prize.

If, for any reason, a Participant's entry is lost, deleted, destroyed or corrupted, the Participant's sole remedy shall be the opportunity to submit a new entry, provided that the Promotion Period has not ended. In the event that the Game is interrupted, in whole or in part, the Promoter reserves the right, at its sole discretion, to conduct the Prize Draw among eligible Participants who successfully entered the Game prior to such interruption.

The Promoter shall not be liable, and no claim may be brought against it, in the event of force majeure or any unforeseen circumstance beyond its reasonable control (including, without limitation, strikes, adverse weather conditions, electronic communications failures or Internet outages) preventing Participants, in whole or in part, from participating in the Game or preventing the Winner from receiving the Prize.

Neither the Promoter nor its suppliers or partners shall be liable for any incident arising from the use of the Prize by the Winner.

Likewise, neither the Promoter nor its suppliers or partners shall be liable for any loss or theft of the Prize once it has been delivered to the Winner. Any additional costs associated with receiving or using the Prize shall be borne exclusively by the Winner.

▼ **ARTICLE 12: GOVERNING LAW AND CLAIMS**

Subject to applicable mandatory laws, Participants agree that:

- any dispute, claim or cause of action arising out of or relating to the Game shall be resolved individually and, where possible, amicably, without resort to any form of class action;
- any judgment or award shall be limited to the reimbursement of actual out-of-pocket expenses incurred in connection with participation in the Game;
- under no circumstances shall Participants be entitled to recover any indirect, incidental or consequential damages.

These Official Rules, and any dispute relating to their drafting, validity, interpretation, performance or enforcement, as well as the rights and obligations of the Participants and the Promoter, shall be governed exclusively by the laws of France.

Any claim relating to the Game must be submitted to the Promoter within one (1) month following the end of the Promotion Period. After this period, no claim shall be accepted.

Participation in the Game constitutes full and unconditional acceptance of these Official Rules.

▼ **ARTICLE 13: EVIDENCE AGREEMENT**

It is expressly agreed between the Participant and the Promoter that the Promoter's electronic systems and computer records shall constitute valid evidence.

Electronic records stored within the Promoter's information systems under reasonable conditions of security and reliability shall be deemed evidence of communications and transactions between the Promoter and the Participant.

Accordingly, unless proven otherwise, the Promoter may rely upon any programs, data, files, records, operations or other information generated, received or stored, directly or indirectly, within its information systems as evidence of any act, fact or omission.

Such records shall be admissible, valid and enforceable between the parties under the same conditions and with the same evidential value as paper documents.

Any operation carried out using the identifiers assigned to a Participant shall be deemed to have been performed by that Participant and under their sole responsibility.
